<sup>3</sup> Only the first \$100 of all contributions combined from a contributor may be in cash. Any contributions above an aggregate of \$100 must be by personal check or credit card.

<sup>4</sup> The law requires disclosure for each itemized contribution made by a lobbyist, the spouse of a lobbyist or any dependent child of a lobbyist who resides in the lobbyist's household. General Statutes § 9-608 (c) (1) (H). The term lobbyist includes anyone required by law to register as a lobbyist with the Office of State Ethics because they (a) expend or agree to expend \$2,000 or more in a calendar year on lobbying; OR (b) receive or agree to receive \$2,000 or more in a calendar year for lobbying. General Statutes § 1-91. Individual lobbyists may contribute to candidate committees and exploratory committees for municipal office up to the limits for those offices.

<sup>5</sup> A "business with which you are associated" refers to any business in which the contributor is a director, officer, owner, limited or general partner, or stockholder of 5% or more of the total stock of the business.
